- Transactions made via third-party takeaway platforms or delivery services are not eligible for this promotion.

- Langham Place HK\$50 Conditional Dining e-Voucher can be used upon net every purchase of HK\$200 or above made at the designated participating merchants. Participating merchants of Langham Place HK\$50 Conditional Dining e-Voucher are listed on Langham Place website.
- Members can use more than one (1) e-Voucher in a single transaction. A maximum of three (3) e-Vouchers can be used in a single transaction. Different types of Conditional e-Voucher cannot be used in the same transaction. Please present the e-Voucher to staff before payment.
- Only Langham Place e-Vouchers (including e-Vouchers and Conditional e-Vouchers) from the same member account can be used in a single transaction.

A valid sales receipt must be machine-printed and contain the name of the shopping mall, merchant name, receipt number, transaction date, transaction time and transaction amount ("Eligible Sales Receipt").

Members are required to present valid same-day electronic sales receipts issued by participating merchants together with corresponding electronic payment slips or screenshots of mobile payment transactions for redemption to join this promotion. Validity of sales receipt is subject to date & time of receipt issuance.
3. Each Eligible Sales Receipt can be registered for this promotion once only.
4. Members shall present the original sales receipt for registration. Revised, re-printed, copied or handwritten receipt is not acceptable. All sales receipts presented will be stamped by Customer Service Ambassadors for internal records.
